## **Objectives for the current mandate:**

Make sure the objectives are *Relevant, Aligned* with ATIA's overall strategic goals and committee description, *Specific* to the Committee and *Attainable* within a clearly defined and realistic timeframe.

- 1) Ensure all Committee members have a good understanding of the current POARA/PGA situation and changes to legislation (what does this mean for ATIA and achieving title protection)
- 2) Develop a Public Relations Strategy and work plan focusing on Who ATIA is and WHY it is important to use Certified Translators and Interpreters
- 3) Develop materials that express the above and send them to specific groups that utilize Translators and Interpreters
- 4) Continue to connect with our Government of Alberta Ministry of Advanced Education contacts and stay apprised of the PGA legislation, timelines, and when/how ATIA can apply for title protection

## **Objectives completed to date:**

## Obstacles or issues encountered, and what steps have been taken to resolve these:

- Delays with the progress of the PGA legislation → out of our control; maintain a good relationship with Government of Alberta Ministry of Advanced Education contacts
- 2) Quorum for monthly meetings/ committee members not available → some meetings were canceled; others were changed to a new date/time that worked better for the majority of the committee members; email was used to share information and get feedback from committee members when meeting was not possible
- 3) There is a lot to know and learn about Title Protection within Alberta and what is required for ATIA to apply (NOTE: applications to apply are not open yet and likely won't be until spring 2027). This concern was brought to the ATIA Executive Council at the September 2025 board meeting, and it was decided to split the committee into 2:
  - 1 committee for Title Protection that will be by appointment only (Members of this committee must have a good understanding of the Alberta Provincial Government, Legislative policy and procedures, and be able to read and understand legal documents)
  - 1 committee for Public Relations



The descriptions for the now 2 separate committees are as follows:

#### **Public Relations Committee:**

#### (Open to Associate and Certified Members)

This committee is made up of a dedicated group of Associate and Certified ATIA members and is responsible for managing the organization's image and communications with the public, media, and stakeholders. This committee's core tasks include supporting fundraising and community engagement initiatives by raising public awareness of ATIA, its mission, as well as promote events, campaigns, and successes.

#### **Title Protection Committee:**

This is a closed committee; all members are appointed by the ATIA Executive Council.

The committee is mandated to conduct thorough research, engage with the appropriate authorities and entities, and adhere to all required procedures (as laid out within the PGA Legislation and Application) in pursuit of Title Protection for ATIA. In close partnership with the Development Coordinator and the President, committee members will coordinate outreach to relevant stakeholders, government bodies, and sector partners throughout Alberta. These efforts will focus on communicating the critical role of ATIA, the rigor of its certification processes, its commitment to high professional standards, and the significance of its Code of Ethics.

### **Comments and observations:**

Over the reporting period, the Committee held nine meetings (6 internal and 3 with Government of Alberta officials) in which the committee achieved significant progress toward both public relations and title protection goals. Key accomplishments included developing and distributing new ATIA promotional materials, strengthening relationships with provincial stakeholders, and maintaining active engagement with the Ministry of Advanced Education regarding the Professional Governance Act (PGA). Despite delays in the PGA rollout and occasional quorum challenges, the Committee adapted effectively and recommended a structural division into two focused groups—Public Relations and Title Protection—to better align with ATIA's strategic priorities. These efforts have reinforced ATIA's visibility, advocacy, and readiness for future regulatory advancement.

# **Next steps/Future goals:**

#### 1. Public Relations Committee

Primary focus: Strengthening ATIA's visibility, public trust, and stakeholder engagement.

Recommended next steps:

- Expand outreach: Continue building relationships with Alberta municipalities, registries, and community organizations that rely on translators and interpreters. Follow up on the 2025 mail-outs to assess awareness and gather feedback.
- Public education campaign: Launch short online or community campaigns emphasizing the value of certified professionals, client safety, and translation quality standards.



- Collaborate with other committees: Work with the Events & Professional Development Committee to promote professional growth and highlight member success stories.
- Media and partnerships: Seek collaboration with language service providers, universities, and cultural
  organizations to co-host awareness events or panels on professional standards.

Goal: Build broad, sustained public and stakeholder recognition of ATIA as the authoritative voice for translators and interpreters in Alberta and to better communicate *Who ATIA is* and *why certification matters*.

#### 2. Title Protection Committee

Primary focus: Preparing for ATIA's application under the Professional Governance Act (PGA).

#### Recommended next steps:

- Develop readiness documentation: Create a clear roadmap for application submission once the portal opens (expected 2027), including timelines, criteria, and responsible leads. (this will require updating old documents from previous submissions and/or requesting new letters of support)
- Maintain GoA engagement: Continue consistent communication with Advanced Education contacts to receive early updates on regulations, templates, and procedural changes. This will ensure compliance and accuracy in application materials.
- Internal education: Offer information sessions or briefings for ATIA Council and members to explain the significance of Title Protection and ATIA's readiness steps.
- Collaboration with other PROs: Connect with associations that have successfully transitioned under the PGA to learn best practices and avoid common pitfalls.

Goal: Position ATIA to submit a strong, complete, and timely application for Title Protection under the PGA, demonstrating readiness, governance strength, and public accountability.
